Travel

There are frequent flights from most Southern California airports to the Sacramento International Airport. Complimentary airport shuttle is available by calling the hotel after arrival. Valet parking is available for hotel guests the rate of \$18 a day for overnight (in and out privileges are allowed) or \$4 per hour with an \$18 cap for non-guests. There is a city parking garage directly across the street for self-parking.

The conference hotel is the Embassy Suites Hotel, 100 Capitol Mall. It is located on the Sacramento River, one half mile from the State Capitol and directly across from Old Sacramento and near Raley Field, home of the Sacramento River Cats.
