The dates below are California State PTA deadlines for districts.

Councils and districts set their own deadlines in order to meet the State deadlines.

All memberships received in the California State PTA office postmarked after March 31 will be included in the membership totals for the following year.

Remittances of "per capita" go through PTA "channels"!

("per capita" means per person and is the portion of membership dues not belonging to the unit PTA)

- ♥ The council PTA remits to the district PTA.
- ♥ The district PTA remits to California State PTA.
- ♥ California State PTA remits to National PTA.

UNIT MEMBERSHIP AWARDS CRITERIA

Early Bird 15 MEMBERS

Certificates from California State PTA will be distributed through district PTAs to each unit PTA that remits per capita dues for 15 or more members, through PTA channels (unit to council, to district, to state) which are postmarked to the California State PTA office from the district PTA by November 1. No application is required.

Chairman's Club 50 MEMBERS

Certificates from the California State PTA will be distributed through district PTAs to each unit PTA that remits per capita dues for 50 or more members, through PTA channels (unit to council, to district, to state) which are postmarked to the California State PTA office from the district PTA by November 15. No application is required.

PTA Spotlight Award APPLICATION TO BE SUBMITTED

Membership and Outreach are part of the PTA Spotlight Award application. Awards will be presented by the California State PTA president to unit and council PTAs at the annual California State PTA Convention. An application must be completed and received in the California State PTA office by February 1. Units must be members of the Chairman's Club in the year they apply in order to be eligible for an award.

Membership Challenge ANNOUNCED YEARLY AT CONVENTION

Acknowledgement will be conferred at the annual California State PTA Convention and award certificates will be mailed to winning PTAs. 2009-2010 Membership Challenge: 5% increase for units and councils. No application required.
